[the "Consumer"], being the party to whom SP PowerAssets Limited (UEN: 200302108D) (the "Transmission Licensee") is providing transmission services (through its Transmission System) at the premises located at _____ (Address) [the "Premises"], acknowledge and agree that: (a) the inverters of the solar photovoltaic system(s) installed or to be installed by the Consumer at the Premises (the "Solar PV System") shall automatically disconnect from the Transmission System in the event of any loss of supply from the Transmission System (such event being a "Loss of Mains"); (b) upon the occurrence of a Loss of Mains, the Solar PV System shall not be able to feed electricity to the Transmission System; and (c) upon restoration of power supply from the Transmission System, the inverters of the Solar PV System shall automatically synchronise and connect with the Transmission System.

In consideration of the Transmission Licensee providing, and continuing to provide, the above transmission services, I/ we: (1) agree that the Transmission Licensee shall not be liable to the Consumer in respect of any loss, damage, costs or expenses of any nature whatsoever arising as a result of, or in connection with, the operation of the Solar PV System, including but not limited to any damage whatsoever caused to the Solar PV System as a result of or in connection with the Loss of Mains; and (2) shall indemnify and keep indemnified the Transmission Licensee for all losses and liabilities incurred by the Transmission Licensee arising, whether directly or indirectly (including as a result of third party claims), from the operation of the Solar PV System. Nothing herein shall affect in any way whatsoever, the terms and conditions of the agreement between the Transmission Licensee and the Consumer (if any) pursuant to which the above transmission services are provided.

It is hereby agreed and acknowledged that by the Consumer signing below on this Letter of Consent and returning it to SP Services Limited, this Letter of Consent shall have the effect of a binding contract between the Consumer and the Transmission Licensee from the date written below.
